**Explanations Highway Development and Planning**

## 1. (d)

A semi-official technical body known as Indian Roads Congress (IRC) was formed in 1934 at the instance of central government. It was the main recommendation of Jaykar Committee. IRC is now an active body of national importance, which controls specifications, standard and guidelines on materials, design and construction of roads and bridges.

## 2. (c)

Motor vehicle act enacted in 1939, which replaced the first such etc, 1914. It has been revised in 1988.

## 3. (a)

According to the Third Road Development Plan in the Lucknow plan (1981-2001), roads should be classified for India as follows:

- (i) Primary system - Expressways and National Highways.
- (ii) Secondary system - State Highways (SH) and Major District Roads (MDR)
- (iii) Tertiary system (Rural road) - other district roads and village roads.

## 4. (b)

- Map study has to be conducted along obligatory points. Obligatory points are the points through which
  - (i) Alignment must pass.
  - (ii) Alignment should not pass.
- Reconnaissance involves visiting the site and examining the general characteristics of the area before deciding the most feasible routes for detailed studies. Details to be collected during Reconnaissance :
  - (i) Obstructions along the routes, e.g., valley, ponds, marshy land etc. which are not listed on map.
  - (ii) Approximate values of gradients.

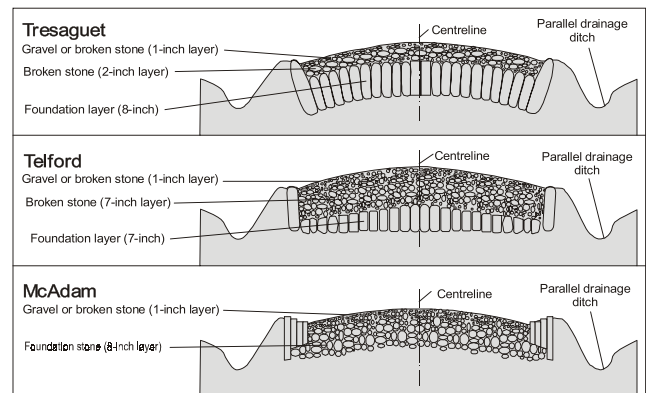
(iii) Number and types of cross drainage structures, HFL and water table.

(iv) Construction material source and its availability.

(v) Soil type, its identification tests and details of geological formation.

Preliminary survey is done after the Reconnaissance to get the best alignment of road. Detailed survey involves establishing the grade line and centre line. Next step is to collect information necessary for preparation of plans and construction details for highway project.

## 5. (b)



Tresaguet construction was started in 1764 AD in France. Telford construction was started in 1803 AD in London (England). Macadam construction was started in 1815 AD in England. CBR construction was started in 1928 AD in USA.

## 6. (a)

- Central Road Fund was established in March 1, 1929.
- IRC was established in 1934.
- Motor Vehicles Act was established in the year 1939.
- Nagpur Road Conference happened in 1943.

7. (d)

Assuming utility units, for population

$$< 2000 = 1.0$$

$$< 2000 - 5000 = 2.0$$

$$> 5000 = 3.0$$

Utility per unit length,

For load

$$A = \frac{8 \times 1.0 + 6 \times 2 + 1 \times 3}{20} = 1.150 \quad \dots(iii)$$

For load

$$B = \frac{19 \times 1.0 + 8 \times 2.0 + 4 \times 3}{28} = 1.679 \quad \dots(ii)$$

For load

$$C = \frac{7 \times 1.0 + 5 \times 2.0 + 2 \times 3.0}{12} = 1.92 \quad \dots(i)$$

8. (b)

According to Nagpur Plan, Indian roads have been classified into 5 categories:

- (i) National highways
- (ii) State highways
- (iii) Major district road
- (iv) Other district road
- (v) Village roads

9. (d)

As per 3<sup>rd</sup> 20 yr plan

Total length of road (km)

$$= \text{maximum} \left\{ \begin{array}{l} 4.74 \times (\text{Number of towns} + \text{villages}) \\ \text{Road density} \times \text{Area} \end{array} \right.$$

We know that,

For 3<sup>rd</sup> 20 yr plan

$$\text{Road density} = 82 \text{ km}/100 \text{ km}^2$$

$$\text{Given, Area} = 13,400 \text{ sq. km}$$

$$\therefore \text{Total length of road} = \left( \frac{82 \times 13400}{100} \right) \\ = 10988 \text{ km}$$

10. (c)

$$\text{Length of NH, km} = \frac{15000}{50} = 300 \text{ km}$$

$$\text{Length of SH, km} = \frac{15000}{25} = 600 \text{ km} \quad \dots(i)$$

$$\text{Also length of SH, km} = 62.5 \times 10 - \frac{15000}{50} \\ = 325 \text{ km}$$

By total no. of towns and area in the state  
adopt length of SH (higher of the two) = 600 km

11. (a)

$$\text{NH} + \text{SH} + \text{MDR} + \text{ODR} + \text{VR} = 15000 \text{ km}$$

$$\left. \begin{array}{l} \text{Length of MDR} = \frac{15000}{12.5} = 1200 \text{ km} \\ \text{or} = 90 \times 10 = 900 \text{ km} \end{array} \right\}$$

By no. of towns in the state,

adopt 1200 km

$$\text{NH} + \text{SH} + \text{MDR} = 300 + 600 + 1200 \text{ km} \\ = 2100 \text{ m}$$

Tertiary system or Rural Roads consists of ODR and VR.

$$\therefore \text{Length of Rural Road} = 15000 - (2100) \\ = 12900 \text{ km}$$

12. (a)

Nagpur road plan formula were prepared by radial or star and grid pattern. Villages with population of 501-5000 only were considered. Agricultural area and non agricultural areas were considered. There were no consideration mentioned for existing Panchayat union, existing mud track records or existing drainage network.

13. (b)

$$(i) \text{ Length of National Highways (NH)} \\ = \text{Area of the country}/50$$

$$(ii) \text{ Length of State Highways (SH)} \\ = \text{Area of the state}/25 \\ = 62.5 \times \text{number of towns in the state} \\ - \text{Area of the state}/50$$

$$(iii) \text{ Length of the Major District Roads (MDR)} \\ = \text{Area of the State}/12.5 \\ = 90 \times \text{number of towns in the state}$$

(iv) Total length of all categories of roads in a district i.e.

$$\text{NH} + \text{SH} + \text{MDR} + \text{ODR} + \text{VR} \\ = \text{Area of District} \times 0.82$$
